Further to the announcement made by Debenhams plc (in administration) (the "Company") on 9 April 2019 confirming the appointment of administrators, the sale of the group pursuant to a pre-packaged sale and the suspension of the Company's ordinary shares of £0.01 each, the Company announces that the listing of the Company's ordinary shares on the Official List of the Financial Conduct Authority was cancelled with effect from 8.00 am (London time) today, 10 April 2019. The Company's ordinary shares ceased to be admitted to trading on the London Stock Exchange's Main Market for listed securities with effect from the same time.

The Administrators also intend to liaise with the Depository of the American Depository Receipt ("ADR") programme, with a view to terminating the ADR programme.
